



## Outline the Fee Arrangement

When meeting with possible auto accident attorneys, you'll likely go over their rates and fees. Many don't charge anything until and unless you win or settle. Find out what percentage of the award will go the lawyer. The going rate is between one-third and 40 percent of the total award. Ask for a printout of fees and hourly rates so you can refer to it later. Of course, this number is not set in stone. Many factors affect the total bill, from the complexity of the case to longevity of the case. Car accident lawsuits can last months or even years and they're not all cut and dried. Things have to be proven, filed and verified, and that all takes time.

- ✓ Frequently of handling similar cases with similar resulting injuries.
- ✓ Membership in bar associations or professional organizations.

## Assess the Consultation Later
